### 2024 IN PERSON TRAINING PROGRAMME COURSE INFORMATION SHEET

#### What is the aim of the course?

The course is aimed at providing candidates with an understanding of the general principles of mediation and its relationship to other dispute resolution processes. The course will introduce candidates to the legal position of, and good practice and procedure in, mediation.

The course is intended for candidates who are new to the field of mediation, wish to learn more about mediation and its benefits to users, or wish to become Associate members of the Chartered Institute of Arbitrators (Ciarb). Ciarb membership provides a world-class qualification demonstrating excellence in ADR. Becoming an Associate member is a step through Ciarb's world-renowned training programme to become a Ciarb Member.

#### What is covered within the syllabus?

Through private study and virtual lectures and tutorials, candidates will learn and gain knowledge of:

- The nature of conflict
- How mediation differs from other forms of conflict resolution
- The principles of mediation
- The models of mediation
- The core skills of a mediator
- The structure of a mediation meeting

#### What are the learning outcomes?

On successful completion of this course, candidates will be able to:

- Understand the background to mediation.
- Describe the process and procedure of mediation.
- Understand mediation in the context of other forms of dispute resolution.

#### What are the entry requirements?

There are no pre-requisite academic or experience entry requirements for this course other than English language competence since training and assessment are carried out in English. It is therefore essential that candidates are proficient in both written and spoken English.

#### What is the enrolment process?

To enrol on the course, submit the completed Registration Form to the Course Administrator at <a href="mailto:info@ciarbcaribbean.org">info@ciarbcaribbean.org</a>
NO LATER THAN 1 OCTOBER 2024. Upon successful registration on the course, candidates will receive confirmation that they are provisionally booked on the course, subject to full payment of the course fee, and instructions on how to pay the fee by wire transfer to the Ciarb Caribbean Branch London Bank Account. Wire transfer is the only method of payment.

Upon payment of the fee, registration will be confirmed. Candidates will receive joining instructions, course materials and the course schedule by email but not earlier than the above closing date for registration.

#### What is the course fee and what does it include?

The course fee is US\$400.00 or its equivalent in GB£ at the time of invoicing. The fee includes registration, study materials, refreshments and lunch, tuition and assessment. Ciarb Student members are entitled to a 10% discount.

#### How is the course delivered?

The course is delivered with a combination of private study and in person lectures and tutorials. Private study includes reading course materials and undertaking self-assessment tasks in the candidates' own time. In person lectures and tutorials involve the candidates attending one full-day in person classroom on Friday, 18 October 2024 starting at 9:00 am (Eastern Caribbean Time) at the Hyatt Hotel, Port-of-Spain, Trinidad & Tobago.

#### How will candidates be assessed?

Candidates will be assessed on the basis of an online multiple-choice test accessed via LearnADR, Ciarb's online learning platform from 20 October 2024 and available for 28 days from that date. Prior to the start date of the assessment period candidates will receive an email with their username and password.

Candidates will be allowed three attempts to complete the test. Each attempt started must be completed with 7 days of its start. All attempts must be completed and submitted within the 28-day assessment period. Candidates must achieve a minimum overall mark of 55% to pass the course. Results are made available to candidates immediately upon completion of the assessment.

On successful completion, candidates will be awarded a Certificate of Assessment, will be eligible to apply for Associate grade membership of Ciarb and take advantage of a range of educational and professional benefits and may progress onto the Module 1 course in Mediation.
